

Lazy F Camp and Retreat Center
Release, Assumption of Risk and Waiver
Yakima River Float Trip
(For Junior and Senior High Camps)

Please read this document completely before signing it. Its effect is to release the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center from any liability resulting from your participation in the Yakima River Float Trip, and waives all claims for damages or losses against the Pacific Northwest Annual Conference, Camping Board of Stewards, Lazy F Camp and Retreat Center, and any of their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf.

I, _____, (full, legal name) intend to participate in a Float Trip on the Yakima River, sponsored by the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center.

I certify that I (my child, if participant is under 18 years of age) am (is) able to participate in the Yakima River Float Trip, including transportation to and from the Float Trip. If I (my child) have (has) a medical condition that may be relevant to a physician in the event of an emergency, I have listed such conditions on the camp's Health History Form. In the event an emergency occurs, I hereby authorize the Health Care Provider to make emergency medical decisions for my child.

I shall not hold the Pacific Northwest Annual Conference (PNWAC), the Camping Board of Stewards (CBS), Lazy F Camp and Retreat Center, nor any of their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (henceforth referred to as PNWAC, CBS, and Lazy F Camp) liable in any way for any occurrence in connection with the activities described above, even if such activities result in injury, death, dismemberment, injury to reputation, emotional distress or other damages to me (my child), or my (child's) family, heirs, or assigns. I shall save and hold harmless PNWAC, CBS, and Lazy F Camp from any claim by me, my family, estate, heirs, or assigns arising out of my (my child's) participation in this activity.

In consideration of (my child) being allowed to take part in the activities described above, I hereby personally assume all risks in connection with the activities, for any harm, injury, damage, or possible death that may befall myself (my child) while traveling to and from the Float Trip sites and participating in the Float Trip itself, including all risks connected therewith, whether foreseen or unforeseen.

I shall exempt and release PNWAC, CBS, and Lazy F Camp from all liability whatsoever for personal injury, property damage or wrongful death caused by negligence. I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by law and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release contains the entire agreement between the parties hereto, and the terms of this release are contractual and not a mere recital. The parties shall resolve any dispute arising under the agreement only through negotiation, mediation, or binding arbitration.

I further state that **I HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW THE CONTENTS THEREOF AND I SIGN THIS RELEASE AS MY OWN FREE ACT.** This is a legally binding agreement that I have read and understand.
