Please read this document completely before signing it. Its effect is to release the Pacific Northwest Annual Conference (PNW), Camping Board of Stewards, and Lazy F Camp and Retreat Center from any liability resulting from your participation in Wilderness Expedition and waive all claims for damages or losses against the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center.

I, _____, (full, legal name) intend to participate in Wilderness Expedition sponsored by the Pacific Northwest Annual Conference, PNW Conference Camping Commission, and Lazy F Camp and Retreat Center.

In consideration of the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center making arrangement for and permitting and assisting me in participation in the above named activity, I exercise my own free choice to participate voluntarily and promise to take due care during such participation. I hereby release and discharge, indemnify and hold harmless the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center and their members, officers, agents, employees, and any other persons or entities acting on their behalf, and the successors and assigns for any and all of the aforementioned persons and entities, against all claims, demands, and cause of action whatsoever, either in law or in equity, relating to injury, disability, death and other harm, to person or property or both, arising from my participation in Wilderness Expedition.

Furthermore, I am aware that activities during Wilderness Expedition may include occurrences and situations beyond human control, creating hazards which could place me in perilous situations. Although not common, these hazards include but are not limited to: rapidly moving water, rocks and other obstacles, extremely cold or warm temperatures, frostbite, hypothermia, sunburn, dehydration, high altitude disorders, dust storms, lightening, flash floods, rock fall, failure of equipment, wild and domestic animals, motor vehicles on and off road, insect bites and related diseases, and perils not specifically named herein.

I acknowledge that I have been informed of hazards and risks which may be associated with my participation in Wilderness Expedition. I understand, accept, and assume those hazards and risks, and waive all claims against the Pacific Northwest Annual Conference, Camping Board of Stewards, and Lazy F Camp and Retreat Center and all other persons as set forth above. I understand that I am solely responsible for any costs arising out of any bodily injury, property damage, medical evacuation expense, or rescue expenses sustained through my participation in the above named activity.

Furthermore, I acknowledge that the skills, techniques, and knowledge that this activity exposes me to may not be sufficient training or background to safely and competently perform this activity without additional professional instruction.

I have had sufficient time to review and seek explanation of the provisions contained above, and have carefully read them, understand them fully, and agree to be bound by them. After careful deliberation, I voluntarily give my consent and agree to this Release, Assumption of Risk and Waiver.
